

I do like change when it has a purpose...



If there is one thing I have discovered in life it is that there is always someone who wants to question your motives whenever you attempt to challenge the status quo or to suggest that acquired tradition might just be the result of an historical oversight that has been allowed to continue unchallenged. Let's be honest, we can all attest to the truth I recently heard, when a Lodge secretary informed the visiting Brethren that they had just witnessed some of the amazing traditions of the Lodge - including some that had occurred for the very first time that same evening. It drew a laugh, and the many nodding heads confirmed that

what he said was absolutely true.

When I was Invested as Provincial Grand Master in October 2022 I informed my team that our journey would be one punctuated by change. Some of the changes would be as a result of initiatives from the Centre (the UGLE), but most of the changes would be inspired from within the Province. However, what I would not encourage is change for change's sake. There has to be a reason for change.

Recently the Communication Team produced the latest booklet designed to assist Provincial and Lodge Directors of Ceremonies in managing the protocols surrounding the Installation Meeting. It might come as a surprise to some Brethren to know that there are set processes, procedures, and elements of the ceremonial that are common to every Installation, and to which every Lodge is expected to conform. In simple terms the rule is that whenever a Provincial Ruler presides at a meeting, the Installation Meeting being the most common, Provincial Grand Lodge Rules apply.

What has pleased me and the Provincial Director of Ceremonies, is the way in which the majority of Lodges have 'signed up' to the new way of doing things. In fact, quite a few Lodges have commented on the fact that the incoming procession is much smarter and looks more controlled, while some Brethren have welcomed the way in which the Provincial Grand Stewards have brought an element of colour to proceedings. The Deputies, and Assistant Directors of Ceremonies are required to carry their Batons, even when attending in support of the active officer. Small changes but carrying significant meaning.

I'm pleased to say that Barry and his team have some new ideas and plans for Provincial Grand Lodge in October, yet another reason to attend what is the showcase of Wiltshire's Masonic year.

The Summer edition of Across the Plain contained the official summons for Provincial Grand Lodge. The summons is also sent to you with this edition of In touch > On line. I would ask that you read the comment on 'Why you should attend Provincial Grand Lodge' - I trust it will make you think about the importance of a promise.

I was particularly pleased to visit Salisbury Hospital to be given a comprehensive briefing on the work of The Stars Appeal, and what a superb job they do. I was delighted to present a cheque for £1,000 that will go towards providing items which are not core to the NHS provision. (See page 6)

Having visited Salisbury Hospital it was only right that the following week found me in Swindon and the Great Western Hospital, whose version of The Stars Appeal is 'Brighter Futures'. It is humbling and inspiring to witness the generosity of the Lodges that support local organisations doing such great work.

In the 2017 Festival the Communication Team designed a pillar that was updated on a regular basis and formed part of the Festival web page. To be quite honest with you, it was a flop. Hardly anyone looked at it, and those that did didn't believe it was accurate, and they were right. Rather than present inaccurate and misleading information we have decided that we won't be repeating that exercise.

However, we do recognise that Lodges want to know how they are doing and we will be reporting individual Lodge progress through the Lodge Charity Steward. Funds continue to flow into our Provincial Wiltshire 2028 Festival Relief Chest No.E2028 and that money is growing at an astonishing rate of six per cent per annum. I am sure you will agree this is a great incentive for your Lodge to release the money to E2028 as soon as possible.

Please don't forget that Alan Colman, and Richard Legge are gearing up for the first of the cycle rides in support of the Wiltshire 2028 Festival on Sunday 3rd September 2023 – starting at 9.00am from The Planks, Swindon, and will include visits to Highworth, Calne and Marlborough. Sources suggest that the members meeting at the locations will be providing refreshments to riders and supporters. Why should you attend Provincial Grand Lodge?

To the Freemason a promise, pledge and/or vow should be adhered to without evasion, equivocation or mental reservation of any kind. In fact that is what each of us commits to do as we kiss or salute the Volume of the Sacred Law. Every Freemason understands the gravity of the undertaking he makes as he "solemnly promises and swears" to observe the parts and points recounted by the Master; yet for some Freemasons it would seem to be the case that a promise, pledge or vow is really nothing more than an aspiration, a hope or an ambition.

This is potentially problematical as keeping a promise lays the foundation for trust and respect. When our behaviour is consistent, it allows others to build faith in us. One of the biggest consequences of not keeping our word is that it can damage our reputation as people who don't keep their word are often perceived as being unreliable. This can make it difficult to establish and maintain relationships, as others are likely to be hesitant to trust you in the future.

The Emulation book of ritual is peppered with phrases that indicate the importance of a Freemason's word being his bond and something on which his Lodge and a Brother can rely. Who can forget the solemn pledge undertaken by the new Master Mason as he engaged in the act of demonstrating the five points of fellowship?

Promising to "obey all lawful signs and summonses sent from a Master Masons' Lodge" is something that we do twice in our Masonic journey and it is the promise that some Freemasons feel is the least important to keep. Having been told there are six, seven or eight meetings a year, and having affirmed that you will support the Lodge and be a regular participant in its activities, suddenly another event takes precedence and the Lodge is deprived of your presence. Tough at the best of times, but more so when holding a Lodge office.

Promises are hard work and rightly so for if following through on a promise was easy, then broken promises wouldn't hurt so much.

Promises are usually hard because they require us to step outside of our wants and fulfil something for someone or something else.

Promises are meant to be taken seriously; after all when a promise is broken, our reputation, relationships and personal integrity suffer.

Promises are commitments, whether the commitment is to ourselves or to someone else. Making a promise is a commitment that you will keep your word. It is a commitment that reinforces trust.

Promises should never go beyond our own boundaries. In other words, never make a promise you can't keep. Have the courage to stay true to yourself and tell them you can't fulfil the pledge, vow or promise.

So here's the rub. Every Master Mason promises to "answer and obey all summonses sent to me from a Master Masons' Lodge". With this edition of In touch > On line you will receive a copy of the summons for the annual meeting of Provincial Grand Lodge on Thursday 5th October at 2.30pm.

If you are a Master Mason you promised that you would answer and obey such a summons. The question therefore is quite simple - will you be there? If you really can't attend (as opposed to you don't want to attend) on the basis of sickness or the pressing emergencies of my own public or private avocations that's fine, but whatever your reason, if you don't intend to attend, please send your apology to the Provincial Secretary.
