

About Akram Elias....

Akram R. Elias began his Masonic journey on 18 June 1996, when he was initiated into the Society of Freemasonry at Potomac Lodge No.5 under the Grand Lodge of the District of Columbia (Washington DC). He received all three degrees of Freemasonry in his Mother Lodge. Since those early days in his Masonic life, Brother Elias has been the Master of several Lodges: La France Lodge No. 93 in 1999; Benjamin B. French Lodge No.15 in 2001; Cincinnatus Lodge No.76 in 2003; and Pythagoras Lodge of Research in 2004, all in Washington, DC.

After a nine year journey starting in December 1999 with the appointment as the Grand Marshal of the Grand Lodge of Washington DC and following a seven year elected line as Grand officer, Brother Elias was installed as Grand Master on 8 December 2007, and served in the Grand East until 13 December 2008, under the theme of *Energize – Engage – Enlighten*.

On 26 April 2023, he received the grand rank appointment of Past Grand Sword Bearer.

Why do we do things?

The history of Giving Greetings immediately after the Third Rising is one of those 'traditions' where its origins have either been lost in the mist of time or as is more usual, completely misunderstood. What is true is that it has become a point of discussion in our Lodges, particularly since the PrGM has asked that at Installation meetings one visiting Brother undertakes the greeting on behalf of all the visitors.

For those avid students of Masonic history the root of greetings can be found in various ancient manuscripts and it is to these documents that we must refer in order to understand the origin of this delightful practice.

The original form of greetings was taught to the Fellow Craft Freemason in order that he could identify himself when visiting another Lodge. It wasn't taught to the Apprentice as it was presumed he would not and indeed possibly could not visit.

The spoken words were "The Worthy Masons and Honourable Company that I come from, Greet you well, Greet you well."

The 1723 Book of Constitutions, that is celebrating its 300th anniversary contains a very important note that helps us to understand little more about 'greetings'.

All particular (that is to say, private) Lodges are to observe the same usages as much as possible; in order to which, and for cultivating a good Understanding among Free-Masons, some member out of every Lodge shall be deputed to visit other Lodges as often as shall be thought convenient.

This suggests that visiting was a more formal exercise and that apart from some form of formal identification to prove a man was a Free-Mason, it was also necessary to inform the host Lodge which Lodge you represented.

It is often forgotten that in the early days of Freemasonry it was only the Master who gave greetings or who authorised another brother to do so on his behalf. Today, when a Master is not present, the senior member present of his Lodge will speak on behalf of the Master. In theory this should only be done with the prior approval of the Master.

As a matter of etiquette, a member of a Lodge should not give greetings in his own Lodge as representative of another Lodge, unless he is the Worshipful Master of that (other) Lodge.

The Provincial Grand Master asks that Brethren adopt the following protocols when giving 'greetings'.

1. Please do not give greetings from more than one Lodge. You are visiting on behalf of a Lodge not a multiplicity of Lodges. "Whilst I'm on my feet" is not something that should ever be said.

2. The correct form of address is "Greetings Worshipful Master from the Master, Wardens and Brethren of the [*Lodge Name and number*]" which incidentally should correspond with the details entered in the Visitors book.

3. Points to remember. The Brother gives greetings and not congratulations, and that greetings are in respect of a single Lodge. Leave congratulations to the Brother responding to the visitor's toast.

The Private Lodge defined....

The comment "We are a Private Lodge" is used by some to justify a disregard for a request or instruction from the Province or from the UGLE. The claim to be a Private Lodge is often accompanied by the rejoinder "and we can do whatever we like." Sadly, the claim to be a Private Lodge and to be able to "do whatever we like" is to misunderstand the constitutional make up of a Private Lodge.

To appreciate the terminology, it is first necessary to reflect on the meaning of two words - Peculiar and Particular. In describing what Freemasonry is we use the word 'peculiar' - as in "a peculiar system of morality". We do not mean that Freemasonry is strange, odd, queer, or even funny, rather we use an old world expression that means special or different.

A good example of the word peculiar being used in this context can be found in the relationship between Church and Sovereign. A royal peculiar is a Church of England parish or church exempt from the jurisdiction of the diocese and the province in which it lies, and subject to the direct jurisdiction of the monarch or, in Cornwall, of the Duke of Cornwall. The clergy and congregation of a royal peculiar would not consider themselves to be strange, but they do consider their status to be special.

In the Antient Charges of a Free-Mason, a summary of which is read to every new Master at his Installation, we are told that "A Lodge may be either general or particular" and it is from the latter that the word private has been generated.

To list all the synonyms describing particular would fill a sheet of this newsletter, suffice to say that individual, and specific are two of the most widely used.

As we are informed, there are only two types of Lodges, and that a Private Lodge is a 'particular' Lodge, it follows that a 'general' Lodge is and must be a Grand Lodge, of which there are four. The Grand Lodge is the governing body of all Freemasonry in England, Wales, and the Channel Islands, while Metropolitan Grand Lodge governs London, Provincial Grand Lodges govern the Provinces, and District Grand Lodges govern those overseas areas outside of London and the UK Provinces.

The term private does not mean that a Lodge, as in its members, can do anything they like or ignore a request or instruction from the Grand Lodge. In fact, it's quite the opposite as every Master promises "strictly to conform to every Edict of the Grand Lodge."

And finally, I was recently asked whether a Master who was not present when his successor was Installed can be invested as Immediate Past Master at some later date, very much like an officer absent at the Installation meeting is Invested on the next suitable occasion (although it should be pointed out that there is absolutely no requirement to do so.)

The answer to the question is not found in the Book of Constitutions but in the booklet titled INFORMATION FOR THE GUIDANCE OF MEMBERS OF THE CRAFT. Such guidance, as it come from the Board of General Purposes should be given equal weight as one might to the Book of Constitutions.

The relevant clause states:- If he is not present at the installation of his successor **he cannot be invested on some later occasion** but is nonetheless the Immediate Past Master.
