Building Together...



Building Together is the theme for this year's Provincial Grand Lodge and is intended to reinforce the initiative from Grand Lodge.

For many of our Members the union of the Antient and Modern Grand Lodges in 1813 will probably be nothing more than something they hear at the presentation of a Grand Lodge Certificate; and yet it is such an important part of our Masonic history

The union was sealed with an historic announcement referred to as the *Preliminary Declaration* the words of which can be found in the Book of Constitutions under the

heading GENERAL LAWS AND REGULATIONS FOR THE GOVERNMENT OF THE CRAFT.

The declaration made clear that English Freemasonry consists of three degrees and no more, viz, those of the Entered Apprentice, the Fellow Craft, and the Master Mason, including the Supreme Order of the Holy Royal Arch. This declaration has been accepted without reservation by English Freemasons for over 200 years. Today, with a few 'cosmetic' changes the declaration remains a key feature of English Freemasonry and forms the basis for a new initiative aptly titled **Building Together**.

Every Master Mason should aspire to continue their journey from Initiation in the Craft to Exaltation as a Companion in the Royal Arch, after all there are four parts to a Freemason's journey. The connection of the Craft to the Royal Arch makes English Freemasonry unique around the world and represents an important part of our history and heritage.

By the time a Brother becomes a Master Mason, it is hoped that he will have learnt a lot during his Masonic journey and having made such progress will have been made aware that his journey is not yet complete because there is more to learn. The Craft starts you on this voyage of discovery, but it is only in the Royal Arch that you learn how to pursue it to the next level

In my address to Provincial Grand Lodge I will be reinforcing the central message and developing the theme of **Building Together**. I will also be pleased to launch Wiltshire's very own **Welcome Companion** booklet, which is designed to assist Companions of the Royal Arch to explain how the metaphorical journey in the Craft is the transition from rough to perfect ashlar, while the Royal Arch represents the completion of that journey — the stage when the perfect ashlar becomes part of a larger, more complete structure.

I am pleased to announce the rollout of **Building Together** which will be launched at Provincial Grand Lodge on Thursday 2nd October. This exciting initiative brings togetherThe Members' Pathway and Archway into a single resource, aligned with our Membership Strategy: One Journey, One Organisation.

The key highlights of the **Building Together** programme:

The journey starts with a man being made a Freemason.

When interviewing candidates for Initiation, it is important to emphasise that they are not only joining a Lodge, as essential as that is, but they are also joining Freemasonry which is more than just an organisation. Their journey will span four stages – three within the Craft and one in a Royal Arch Chapter of their choosing. This final stage completes their journey in Pure Antient Masonry.

Reinforcing the Masonic Journey in Lodge.

Following each ceremony of Initiation, Passing, and Raising, the three special readings that describe a Mason's progress can be read by the Worshipful Master, or a Brother with a special interest in the development of the new Freemason. Copies of these readings will be distributed by the Communication team, and further copies can be accessed online. This practice helps reinforce the meaning and continuity of the Masonic experience.

Distribution of educational material.

Please ensure that the relevant booklets are provided at each stage of a Brother's Masonic journey. Additionally, when a Master Mason receives his Grand Lodge Certificate, please reference the Royal Arch and issue a copy of the "Discover More" booklet, helping to raise awareness and curiosity about the next stage. The booklet is available on the Provincial website on the Craft, and Royal Arch front pages.

I encourage all Lodges and Chapters to embrace and support this initiative. It is only by **Building Together** that we can ensure every Brother is guided, informed, and inspired throughout his Masonic journey.

Blackballing a candidate.

Is it ever right to blackball a candidate? The answer must surely be, yes it is – otherwise there would be no point whatsoever in allowing for such an action in the Book of Constitutions.

The better question might be, under what circumstances is a blackball justified?

It's worth noting that the position with regard to blackballing has given rise to a number of cases that have found their way to Grand Lodge for an opinion or adjudication.

It should be recognised that not every blackballing of a candidate is wrong. Etiquette demands that proper process and procedure should be followed whenever it is suggested that there may be an objection to a candidate.

First and foremost a Lodge is a group of Brethren who meet together to enjoy the Craft and equally importantly, each other's company. This statement suggests, quite correctly, that a Lodge exists primarily for the benefit of its existing members and the harmony of the Lodge, the issue of someone wishing to join the Lodge is a secondary consideration for the members, albeit Grand Lodge and the Province may have a slightly different view.

The key to whether a blackball is justified is grounded on the basis that there are real grounds to a genuine objection to a candidate. This gives rise to clear obligations on the part of the members not to abuse the right to register their objection to a candidate.

Masonic guidance has been provided by the Grand Registrar.

"On the election of a candidate for initiation, or any other election, each Brother has the right to vote, and the right to vote, of course implies a right to blackball. But that right must be exercised in good faith, and is capable of being abused, and the abuse of it may be a Masonic offence. The right is conferred on the understanding that it will be exercised in good faith, and in what are, or what the Brother honestly believes to be, the interest of the Craft in general and the Lodge in particular. Within those limits a Brother can vote as he pleases. He should not use the blackball wantonly or without some definite reason, and he must not do so merely to gratify some personal resentment or as a means of revenge for some real or supposed grievance. Still less must he do so in order to punish or injure some other Brother or Brethren, or to hinder the progress and prosperity of the Lodge. If he so uses the vote, he abuses the right, and is guilty of a breach of the trust imposed in him, and so commits a Masonic offence."

Blackballing a candidate is a serious matter as such it should be avoided if at all possible. For that reason Lodge By-Laws generally carry a short note recommending that any objection be notified to the Master or Secretary who may give the sponsor the opportunity of withdrawing his candidate.

The following words of the Grand Registrar may be considered pertinent, "A Brother... is not bound to disclose whether he voted, or how he voted, or why he so voted; but if it is proved that he deliberately misused the vote – if for instance, he blackballs a Candidate, not because he has any object to that particular Candiate, but in order to be revenged for some real or supposed grievance, or for some similar reason....he has, I suggest to you, done that which will justify the interference of the lodge, and even his exclusion by the Lodge."
